<u>Order</u>

In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Eastern Regional Committee grants recognition to University B.T. & Evening College, Kesab Road, Cooch Behar-736 101 (West Bengal) for B.Ed. Course of one year duration from the academic session 2001-2002 with an annual intake of 50 (Fifty) students, subject to fulfilling the following conditions:

1. Principal and two more lecturers qualified as per NCTE norms shall be appointed by 30.11.2001.

- 2. The institution shall function with Principal, six teaching staff and other supporting staff possessing the qualifications as laid down in the NCTE norms and in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
- 3. Existing five lecturers appointed after 17.8.95 and not qualified shall acquire the qualification as per NCTE norms within two years or be replaced with qualified teachers.
- 4. The institution shall function in general shift and maintain at least 6 hours teaching a day with stipulated teaching days a year.
- 5. The institution shall ensure library with 3000 books, laboratories and other instructional infrastructure as per the NCTE norms within six months.
- 6. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
- 7. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
- 8. Curriculum transaction, including practical work/activities, should be organised as per the NCTE norms and standards for the course and the requirements of the affiliating university/examining body.
- 9. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- 10. The institution shall maintain endowment fund as per NCTE norms within one year.
- 11. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should <u>inter alia</u> give the extent of compliance of the conditions indicated at 1 to 10 above.

If University B.T. & Evening College, Kesab Road, Cooch Behar-736 101 (West Bengal) contravenes any of the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder, or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.

Now, therefore, in exercise of powers vested under Section 18E of the amended NCTE Act, 2006, the Eastern Regional Committee, National Council for Teacher Education hereby validate the qualification of students with retrospective effect passed in different years from the institutions mentioned in para 1 above. The institution shall assue a certificate to each student whose qualification has been validated under Section 18t of the NCTE Act and would also issue a public notice prominently to this effect in two local and one national dailies at their own cost.

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS the institution viz. University B.T. and Evening College, 2. Kesab Road, Kunjabari, Cooch Behar, West Bengal -736101 was granted recognition for conduct of B.Ed. course of one year duration with an annual intake of 50 from the academic session 2001-2002 vide ERC order no. ERC/7-20/2001/2563 dt.05.09.2001.
- AND WHEREAS, the institution viz. University B.T. and Evening College, 3. Kesab Road, Kunjabari, Cooch Behar, West Bengal -736101 has by affidavit dated 05.02.2015 consented to come under New Regulations 2014 and sought for One Basic Unit in B.Ed. course.
- AND WHEREAS, it has been decided to permit the institution to have 4. One Basic Unit of 50 students subject to fulfilling following conditions, namely,
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept ١. in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.
 - The institution shall comply with the various other norms and standards 11. prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from III. the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- The institution shall ensure that the required number of academic staff IV. duly approved by affiliating body for conducting the course should always remain in position.

- 5. Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Eastern Regional Committee, NCTE hereby grants recognition to University B.T. and Evening College, Kesab Road, Kunjabari, Cooch Behar, West Bengal -736101 for conducting B.Ed. Programme of two years duration with an intake of 50 for One Basic Unit of 50 students from the academic session 2015-2016.
- 6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by NCTE from time to time and other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.:
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. If it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
